MOTION TO SET EMERGENCY HEARING ON PLAINTIFF'S REQUEST FOR A TEMPORARY INJUNCTION

COMES NOW the Plaintiff, KEITH A. JAMES ("JAMES"), by and through his undersigned attorney, and moves the Court to set an emergency hearing on Plaintiff's request for the entry of a temporary injunction prohibiting Defendant WENDY SARTORY LINK AS PALM BEACH COUNTY SUPERVISOR OF ELECTIONS ("LINK") from taking any official action with regard to the "candidacy" of Defendant RODNEY BRIAN MAYO ("MAYO") for the position of Mayor of the City of West Palm Beach; to prohibit MAYO from campaigning for the position of Mayor of the City of West Palm Beach; and prohibiting the CITY OF WEST PALM BEACH ("THE CITY") from treating MAYO as a candidate of the position of Mayor of THE CITY in the election scheduled for March 14, 2023, and as grounds therefore would state as follows:

1. This litigation seeks a Declaratory Judgment as well as temporary and permanent injunctions pursuant to Chapter 86, Florida Statute adjudicating the fact that MAYO does not qualify to be a candidate for the position of Mayor of the City of West Palm Beach and to enjoin

MAYO from campaigning for this position. The litigation also seeks the entry of injunctions prohibiting LINK and THE CITY from taking any official action with regard to MAYO's candidacy for the office of Mayor.

2. Pursuant to Section 2.01 of the City of West Palm Beach Code of Ordinances, a candidate for Mayor must have "...continually resided in the city during the six-month period immediately prior to the date of election." A copy of this Section is attached hereto as **Exhibit A**.

3. JAMES is presently a candidate of the position of Mayor, is presently the Mayor of THE CITY, and has met all of the prerequisites to qualify for re-election to this office.

4. As is set forth in the Complaint which has just been filed, a copy of which is attached hereto as **Exhibit B** and is incorporated herein by reference, although MAYO has <u>not</u> resided in THE CITY for a period of six (6) months prior to the election which is presently set for March 14, 2023, he has misrepresented that he has satisfied this residency requirement and has improperly registered as a candidate for Mayor.

5. Should MAYO continue to campaign for this position when he is not qualified to do so, and if LINK and THE CITY continue to treat MAYO as a legitimate candidate, JAMES will suffer irreparable harm since there will be confusion on the part of the electorate as to whether or not MAYO is a legitimate candidate which will not be capable of being avoided or remedied.

WHEREFORE, Plaintiff KEITH A. JAMES moves the Court for the entry of an Order setting an emergency hearing on his request for a Temporary Injunction as soon as possible and for whatever other relief is appropriate.

COMPLAINT FOR DECLARATORY RELIEF AND INJUNCTION

COMES NOW the Plaintiff, KEITH A. JAMES ("JAMES"), by and through his undersigned attorney, and files this Complaint against Defendants RODNEY BRIAN MAYO ("MAYO"), WENDY SARTORY LINK AS PALM BEACH COUNTY SUPERVISOR OF ELECTIONS ("LINK"), and THE CITY OF WEST PALM BEACH ("THE CITY") and alleges:

1. This litigation seeks a Declaratory Judgment as well as temporary, mandatory, and permanent injunctions pursuant to Chapter 86, Florida Statute adjudicating the fact that MAYO does not qualify to be a candidate for the office of Mayor of The City of West Palm Beach, and enjoining MAYO, LINK, and THE CITY from taking any further steps in connection with MAYO'S candidacy for said position.

2. At all times material hereto, JAMES is and was over the age of eighteen years, a resident of West Palm Beach, Palm Beach County, Florida, and is presently the Mayor of THE CITY as well as a candidate to retain his position in the upcoming election scheduled to be held on March 14, 2023.

3. At all times material hereto, MAYO is and was over the age of eighteen years of age and has been a resident of the Town of Lantana, Florida.

EXHIBIT B

4. At all times material hereto, LINK is and was over the age of eighteen years and is the Supervisor of Elections for Palm Beach County.

5. At all times material hereto, THE CITY was and is located in Palm Beach County, Florida and JAMES is the duly-elected Mayor. Defendant MAYO is a candidate for the position of Mayor of THE CITY, however, as is explained below, he is not qualified to pursue this candidacy.

6. Pursuant to The City's Ordinance, Section 2.01, a candidate for Mayor of THE CITY is required to have continuously resided in THE CITY during the six-month period immediately prior to the date of the election and is required to continuously reside in THE CITY during the Mayor's term of office. A copy of this Ordinance is attached hereto as **Exhibit A**.

7. Since the mayoral election is scheduled to be held on Tuesday, March 14, 2023, any candidate who is seeking to be elected to this position is required to have resided in THE CITY since approximately September 14, 2023.

8. On November 14, 2022, MAYO filed an Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates, a Statement of Candidate, a Statement of Financial Interests, a Candidate Oath Nonpartisan Office with office of the City Clerk of West Palm Beach and indicated his intention to be a candidate for Mayor of THE CITY in the upcoming election. Copies of these filings are attached hereto as Composite **Exhibit B**.

Among the representations MAYO made in connection with these filings, was that his residential address was and is 518-520 Clematis St. Apartment 1, West Palm Beach Florida, 33401. Implicit in this representation was and is the fact that he has resided at the Clematis Street address or at another address in THE CITY as of September 14, 2022, and that he intended to reside in THE CITY continuously prior to the date of the election, March 14, 2023. In fact, this statement by MAYO regarding his residence was false; the actual address of his residence as of the date of the commencement six-month required pre-election residency period and possibly including the date of his filing as a candidate was and is 6171 Pine Drive, *Lantana*, Florida 33462; and he has continued to reside at the Lantana address following his filing.

10. It is Plaintiff's position that since MAYO's residence was in the Town of Lantana as of September 14, 2022, at the time of his filing to be a candidate for Mayor of THE CITY on November 14, 2022, and thereafter, he would not satisfy the requirement that he continuously be a resident of THE CITY for the period of six-months prior to the scheduled election; that the address of his "residence" that he stated in the filing was false; and therefore he is disqualified from seeking the position of Mayor.

11. JAMES does not know whether or not LINK is aware of the fact that MAYO cannot qualify as a mayoral candidate for THE CITY, and therefore she has been included in this litigation to enjoin her from proceeding forward with any steps she might be taking as if MAYO was a candidate qualified to seek the office of THE CITY's Mayor. Therefore, an injunction should be issued which instructs LINK to cease taking any steps which she would normally be undertaking as Supervisor of Elections if MAYO was a qualified candidate.

12. Due to the nature of this litigation and the timing of same as well as the relief which JAMES is seeking in this litigation, JAMES lacks an adequate remedy at law. Therefore, this Court should enter temporary and permanent injunctions restraining MAYO from seeking the office of Mayor, and LINK from treating MAYO as a legitimate candidate.

13. Although JAMES is unaware of what measures THE CITY is presently taking with regard to the improper candidacy of MAYO for the position of Mayor, THE CITY should likewise

be temporarily and permanently enjoined from any actions which would treat MAYO as a legitimate candidate.

WHEREFORE, Plaintiff KEITH JAMES demands that this Court issue a Declaratory Judgment which holds that RODNEY BRIAN MAYO is ineligible to seek election for the position of Mayor of The City of West Palm Beach; that this Court issue temporary and permanent injunctions requiring that Defendant WENDY SARTORY LINK, AS PALM BEACH COUNTY SUPERVISOR OF ELECTIONS halt any steps she would normally be taking assuming that RODNEY BRIAN MAYO was a legitimate candidate for Mayor of THE CITY; that THE CITY OF WEST PALM BEACH take those steps necessary to halt the improper candidacy of RODNEY BRIAN MAYO, and that RODNEY BRYAN MAYO be enjoined from taking any steps to further his candidacy. Plaintiff further requests that this Court award costs, and if appropriate, attorney's fees to the Plaintiff in connection with this litigation.


