CITY ORDINANCE VIOLATIONS

On August 26, 2023 at approximately 1730hrs I responded to 1 N Clematis St (Great Lawn) which is a public place owned by City of West Palm Beach and is not Private Property, in response to an ordinance violation. Upon arrival I made contact with Ofc Mendez who advised a line was formed with approximately 20 people awaiting free food from a table with another 10-20 people eating in the same courtyard. Details are as follows:

Upon my approach to the serving tables (2 fold-up tables with numerous food items) I observed at-least 3 crock-pots and numerous bagel/bread bags (enough to feed 30+ people). I spoke to the numerous subjects who appeared to be serving the homeless. These subjects, who had gloves on and appeared to be removing food items and loading them into their vehicles declined being the "one in charge" stating they were just there handing out food to those in need. I requested multiple subjects to identify themselves:

Jacob Robbins (W/M 2/16/96) 954-396-5893 Carly Prinzo (W/F 4/30/97) 954-778-6298 Madeline (Sandy) Matkivich (W/F 5/17/43) Nicolas Cubides (W/M 12/08/87) 561-223-1777.

Vehicles involved: FL-HNM7T Grey Dodge Caravan FL-GZTR98 White Chev Cruze FL- EMGF28 Gold Honda Accord

I made contact and received a Sworn Statement from the original caller Jessica Kelly (Event Coordinator). She advised that at approximately 1600hrs she observed a vehicle parked on the sidewalk unloading food items, she approached to request for the vehicle to be removed. As Kelly approached she observed food plates and people eating around a table approximately 30 or more. Kelly asked Matkivich if she was part of the Ukraine Relief event, which had food and beverages on sale and was a permitted event, and she replied no. Kelly then asked for the "Food not bombs" table and food items to be removed from the area. When Matkivich became aggressive and confrontation towards Kelly, Kelly walked away and contacted WPBPD.

It should be noted that Matkivich was very argumentative and did not want to provide identification to police, and at one point giving an alias of "Sandy".

It should also be noted that Cubides did take a stand for the cause, and although he did not take credit for the event, he acknowledged that he and the organization (Food Not Bombs a non-profit organization) has been fighting state after state for the right to feed the homeless to include a few cities in Florida. Cubides also acknowledged that he did not have a permit to distribute food stating "The city did not issue one."

I contacted WPB STIC in order to review city cameras, and Det Skotzke located the subjects on scene for more than an hour serving food in the city owned property. This video was submitted to Evidence.

All four of the above subjects were cited under West Palm Beach Ordinance 5037-23 for Feeding Over 25 people with a court date of September 26 2023 at 0800. All subjects signed for their Notice to Appear.

The City attorney was made aware of the incident and court date via email. Sgt Flaton Notified and Responded to scene. BWC active.

Large group feeding, includes the term social service food sharing, and means an event intended to attract, attracting, or likely to attract twenty-five (25) or more people, including distributors and servers for the delivery or service of food in a public space including space that is a dedicated or undedicated public street, highway, sidewalk, park, parkway, right-of-way, alley, public way, or any other public places within the city, including city-owned buildings or other city-property. Public space shall also include the buildings of any governmental agency within the city including federal, state, and county owned buildings. Excluded from this definition are activities of city permitted, licensed, or contracted concessionaires, lessees, or licensees.
